STATEMENT OF COUNCIL PROCEEDINGS

February 20, 2023 6:00 p.m.

The City Council of Boone, Iowa, met in regular session in the City Hall Council Chambers on February 20, 2023, at 6:00 p.m. with Mayor Slight presiding. The meeting was also available via Zoom. The following Council Members were present: Byrd, McGinn, Stines, Moorman, Hilsabeck, and Williamson. Absent: none.

Moorman moved; Stines seconded to approve the agenda as presented. Ayes: McGinn, Stines, Moorman, Hilsabeck, Williamson, and Byrd. Nays: none.

Brenda Dryer, Senior Vice President of Ames Economic Development Commission (AEDC) presented the results of the 2022 Business Retention Survey, highlighting potential expansion where 1,020 new jobs could be created.

Mayor Slight canceled the public hearing for the consideration of the sale of property described as: Lots Six (6) and Seven (7) in Block Eleven (11) in Fairview Addition to the City of Boone, Boone County, Iowa.

Williamson moved; Stines seconded to approve Resolution 3078 fixing a date for a public hearing on the proposal to enter into a Development Agreement with BJF Boone Senior, LP, and providing for publication of notice thereof. Ayes: Hilsabeck, Williamson, Byrd, McGinn, Stines, and Moorman. Nays: none.

Mayor Slight announced that this is the time and place for a public hearing to consider setting a Max Levy for Fiscal Year 2024 Budget. Mayor Slight asked if there were any written comments; no written comments were presented. Mayor Slight asked if there were any oral comments; no comments were made. Whereupon, the Mayor declared the hearing closed.

Mayor Slight announced that this is the time and place for a public hearing to consider the adoption of Fiscal Year 2024 Capital Improvement Plan (CIP). Mayor Slight asked if there were any written comments; no written comments were presented. Mayor Slight asked if there were any oral comments; no comments were made. Whereupon, the Mayor declared the hearing closed.

Elmquist requested authorization to submit a request for the use of a .gov domain for both City emails and website for creditability and security. McGinn moved; Stines seconded to authorize Elmquist to submit a request for a .gov domain for emails and website. Ayes: Williamson, Byrd, McGinn, Stines, Moorman, and Hilsabeck. Nays: none.

Elmquist updated the Council on the issue at the State regarding the Property Tax Bill; it has passed the House and is waiting the Governor's signature. This provides the Iowa Department of Revenue the authorization to reduce the rollback to 1.84% and send out the new assessed values to the Counties. The County has fifteen (15) days to update their assessed values and deliver those to the Cities. Iowa Cities then have until April 30, 2023 to certify their budgets.

Andrews introduced Emma Rouse as the new Street Laborer in the Public Works Department.
