# **Engineering Report**

Joe Roenfeldt and Ron Roetzel informed the Commission of their presentation to the IA ANG of the three concept drawings illustrating the Commission's preferences for the location of the IA ANG's proposed expansion.

The Commission discussed IDOT's decision on fee reimbursements. It was the Commission's consensus that the Chair inform the City Administrator of the rationale for IDOT's final reimbursement decision.

Joe Roenfeldt briefed the Commission on the progress of the re-construction of runway 15-33. The project is underway and on schedule. He also presented an application for payment by Wicks Construction for approval by the Commission. The Commission was also informed that possible crop damage may occur during the construction process and recommended that we prepare to reimburse the tenant if necessary, based on actual damage, if any, and crop yields. The Chair called for a vote to approve both the payment application and paydown.

No discussion. The Commission approved the application and drawdown unanimously, 5-0

# Airport Manager's Report

Dale Farnham reported that the May 20<sup>th</sup> Fly-in resulted in over 500 attendees, including 50 visiting aircraft. Commissioner Grabau commented on the number of families with children attending and observed that the attractions such as the Classic cars, aero-train rides, and the plane rides were hugely popular. He recommended that additional activities such as bounce houses or rock-climbing walls be considered for future Fly-ins.

Mr. Farnham voiced his concern over the appearance of the area surrounding the airport sign at the entrance of the driveway. After discussion, the Commission recommended that the Airport Manager forego additional landscaping and resort to rock or brick.
