STATEMENT OF COUNCIL PROCEEDINGS

September 18, 2023 6:00 p.m.

The City Council of Boone, Iowa, met in regular session in the City Hall Council Chambers on September 18, 2023, at 6:00 p.m. with Mayor Slight presiding. The meeting was also available via Zoom. The following Council Members were present: Byrd, Henson, Stines, Moorman, Hilsabeck, Williamson, and Angstrom. Absent: none.

Moorman moved; Henson seconded to approve the agenda as presented. Ayes: Henson, Stines, Moorman, Hilsabeck, Williamson, Angstrom, and Byrd. Nays: none.

Mayor Slight announced that this is the time and place for a public hearing to determine whether dogs owned by Michael McFadden and Beth Hill, known as Daisy and Jax, meet the definition of "Vicious Animals" as defined under the City of Boone Ordinance Chapter 56. Raphael Montag, City Attorney, presented Ordinance Chapter 56, defining vicious animals, incident reports, and pictures of physical injuries of a Boone Area Humane Society employee that was a result of the aggressive behavior from "Daisy" and "Jax". Hill spoke on behalf of her dogs explaining and defending their behavior. Stines moved; Moorman seconded to approve the Order that determines "Daisy" and "Jax" do meet the definition of vicious animals as defined under City Code and are to be euthanized. Ayes: Stines, Moorman, Hilsabeck, Williamson, Angstrom, Byrd, and Henson. Nays: none. Montag advised that McFadden and Hill have thirty (30) days to appeal the decision to the Iowa District Court.

Stines moved; Byrd seconded to set a public hearing for October 2, 2023, at 6:00 p.m. for the consideration of the sale of a portion of the public right of way in the north/south alley between the 700 block of 12th Street and the 700 block of 11th Street, Boone, Iowa. Ayes: Moorman, Hilsabeck, Williamson, Angstrom, Byrd, Henson, and Stines. Nays: none.

Angstrom moved; Henson seconded to approve the Parade Permit Application and route for Homecoming, October 6, 2023, as presented by Shannon Lumley, Boone High School. Ayes: Hilsabeck, Williamson, Angstrom, Byrd, Henson, Stines, and Moorman. Nays: none.

Brenda Dryer, Senior Vice President of Ames Economic Development Commission, updated the Council on the Iowa Housing Authority Grant Program stating they received fourteen (14) applications by the deadline and funded eleven (11) requests in the amount of \$86,338.00, six (6) projects have since been completed.

Moorman moved; Stines seconded to approve the Site Plan and Storm Water Plan for Kate's Landing Subdivision, 400 block of South Marion Street, Boone, Iowa. Ayes: Williamson, Angstrom, Byrd, Henson, Stines, Moorman, and Hilsabeck. Nays: none.

Williamson moved; Byrd seconded to approve Elmquist's request to carry-over \$25,000.00 of Fiscal Year 2023 LOST funds to purchase additional modules with the new software and link it to Laserfiche. Ayes: Angstrom, Byrd, Henson, Stines, Moorman, Hilsabeck, and Williamson. Nays: none.

Andrews introduced Tyler McBride, the new Street Department Laborer employee.

Chief Adams advised the controlled burn of the 1608 Story Street structure has been moved to October 1, 2023, due to technical difficulties.

Skare presented the quarterly progress report for the Council's Fiscal Year 2024 Goals. Stines reported that the soccer fields have been moved from the fair grounds to the Boone Middle School.

Moorman stated he handed out an outline that he put together for a Downtown Sidewalk Program that he hopes for the Council to review, discuss, and budget for Fiscal Year 2025. Skare also provided a Downtown Tree Assessment for review completed by Mike Cornelis, Park Director.

Skare asked for permission to approve opening Hancock Drive Extension once panels have been installed and cured. Moorman moved; Stines seconded to allow Skare permission to approve and open Hancock Drive Extension at the appropriate time. Ayes: Byrd, Henson, Stines, Moorman, Hilsabeck, Williamson, and Angstrom. Nays: none.

Skare advised that a memorial plaque for serviceman Jerry Converse has been placed at the Memorial Park located at the corner of 9th and Story Street, dedicated by his classmates.

Skare explained the issues that have occurred regarding water bills between the new software and the third party company that does our utility billing.

Mayor Slight asked if there were any questions or items to be removed from the Consent Agenda; no requests were made.
