STATEMENT OF COUNCIL PROCEEDINGS

October 2, 2023 6:00 p.m.

The City Council of Boone, Iowa, met in regular session in the City Hall Council Chambers on October 2, 2023, at 6:00 p.m. with Mayor Slight presiding. The meeting was also available via Zoom. The following Council Members were present: Byrd, Henson, Stines, Moorman, Hilsabeck, Williamson, and Angstrom. Absent: none.

Moorman moved; Williamson seconded to approve the agenda as presented. Ayes: Henson, Stines, Moorman, Hilsabeck, Williamson, Angstrom, and Byrd. Nays: none.

Tori McKay, YSS Boone Kids Club Coordinator, provided information on the YSS Kids Club Program that offers before and after school care for children kindergarten through 6th grade at Ledges Elementary. McKay invited the Council to an open house on October 25, 2023, from 5:30 p.m. to 7:00 p.m.

Mayor Slight announced that this is the time and place for a public hearing for the consideration of the sale of a portion of the public right-of-way in the north/south alley between the 700 block of 12th Street and the 700 block of 11th Street, Boone, Iowa. Mayor Slight asked if there were any written comments; no written comments were presented. Mayor Slight asked if there were any oral comments; no comments were made. Whereupon, the Mayor declared the hearing closed.

Stines moved; Hilsabeck seconded to approve Resolution 3137 authorizing the vacation and conveyance of the public right-of-way in the north/south alley between the 700 block of 12th Street and the 700 block of 11th Street, Boone, Iowa. Ayes: Stines, Moorman, Hilsabeck, Williamson, Angstrom, Byrd, and Henson. Nays: none.

Stines moved; Williamson seconded to approve a request to place signs in the City right-of-way for the Airport Chili Feed Fly-In on October 7, 2023. Ayes: Moorman, Hilsabeck, Williamson, Angstrom, Byrd, Henson, and Stines. Nays: none.

Byrd announced that starting in October the Public Safety Committee meetings will move to the last Wednesday of the month due to the availability of the Committee members.

Henson moved; Williamson seconded to approve Resolution 3138 authorizing the execution of a Community Catalyst Building Remediation Grant Agreement with the Iowa Economic Development Authority (IEDA), for the Boone Virginia Theater Building, 926 8th Street, Boone, Iowa. Ayes: Hilsabeck, Williamson, Angstrom, Byrd, Henson, Stines, and Moorman. Nays: none.

Andrews updated the Council on the Sanitary Sewer Lining Project with the three (3) areas staff would like to pursue at Woodland Avenue to Union Street on Story Street, 1st Street to Mamie Eisenhower Avenue on Story Street, and West 7th Street from Division Street to McPherson Street and provided photographs of the sewer issues for viewing.

Chief Adams presented the unique opportunity to partner with the Boone High School's EMT Apprenticeship Program to recruit new Fire Department staff to fill part-time and paid on call positions. Adams introduced Hannah Derry, a Senior at Boone High School, as the first apprentice in the program.

Williamson moved; Henson seconded to approve Resolution 3140 approving the hiring of a new EMT apprentice, Hannah Derry, for the Boone Fire Department with a wage set at \$10.00 an hour. Ayes: Williamson, Angstrom, Byrd, Henson, Stines, Moorman, and Hilsabeck. Nays: none.

Chief Adams stated that they had a successful training session with the controlled burn of the 1608 Story Street structure on October 1, 2023.

The Council discussed the assessment and reports they previously received concerning the condition of the downtown sidewalks and trees. The Council instructed staff to work on and provide a draft of a downtown sidewalk repair policy for review.

Mayor Slight asked if there were any questions or items to be removed from the Consent Agenda; no requests were made.

Stines moved; Byrd seconded to approve the following items on the Consent Agenda: 1) Minutes of previous meetings. 2) Bills payable. 3) Resolution 3139 authorizing the payment of \$140,629.89 to R.H.
