November 20, 2023 6:00 p.m.

The City Council of Boone, Iowa, met in regular session in the City Hall Council Chambers on November 20, 2023, at 6:00 p.m. with Mayor Slight presiding. The meeting was also available via Zoom. The following Council Members were present: Byrd, Henson, Stines, Moorman, Hilsabeck, Williamson, and Angstrom. Absent: none.

Moorman moved; Williamson seconded to approve the agenda as presented. Ayes: Henson, Stines, Moorman, Hilsabeck, Williamson, Angstrom, and Byrd. Nays: none.

Mayor Slight swore in Cory Henson Second Ward Council member.

Mayor Slight swore in Kyle Angstrom At-Large Council member.

Moorman moved; Stines seconded to accept the Certificate of Final Completion for the Ericson Public Library 2023 HVAC Improvements Project. Ayes: Stines, Moorman, Hilsabeck, Williamson, Angstrom, Byrd, and Henson. Nays: none.

Williamson announced that the City Council will host an appreciation luncheon for Mayor Slight and City employees, December 15, 2023.

Williamson moved; Henson seconded to approve the Parade Application and street closures submitted for the Holiday Lighted Parade and Tree Lighting Ceremony, to close Story Street from 6th Street to 9th Street November 30, 2023, 3:00 p.m. to 8:00 p.m. Ayes: Moorman, Hilsabeck, Williamson, Angstrom, Byrd, Henson, and Stines. Nays: none.

Angstrom moved; Hilsabeck seconded to approve the 3rd Contract Amendment for Fox Strand regarding the Wastewater Ultraviolet Disinfection (UV) Improvement Project in an amount not to exceed \$28,500.00 through February 17, 2024. Ayes: Moorman, Hilsabeck, Williamson, Angstrom, Byrd, Henson, and Stines. Nays: none.

Elmquist presented the Tax Increment Financing (TIF) Certification Report that requests to the County Auditor how much to withhold from the City's Urban Renewal Areas. Byrd moved; Henson seconded to approve Resolution 3151 approving the Tax Increment Financing (TIF) Certification for Fiscal Year 2025 and submitting it to the Boone County Auditor.
