# 6. Old Business:

Portable Pro (Greenspace)

A. Update on Playground Equipment Project - Mike Cornelis

The Leonard Good Foundation awarded a grant for \$10,000 to the parks department. This money will be used for new playground equipment for Franklin Park. The city will match up to \$50,000 for the play equipment. Cornelis, with the help of the Park Foundation, will be looking into other opportunities for grants to get the money needed for the city's match. Total price for a new playground structure would be close to \$100,000.

#### New Business:

A. Revenue and Expense work session

Cornelis reviewed the Park Budget worksheets with the commissioners. The budget amounts for the pool, cemetery and parks were discussed.

B. Discussion – possible closing of north entrance to Linwood Park Cemetery

There have been some concerns about drivers using the cemetery to cut through from the north using the cemetery as a short cut to the south part of town. The speed limit is 10 mph in the cemetery and the traffic is going considerably faster than the posted limit. This is a safety concern for pedestrians and other visitors in the cemetery. It was suggested putting up a gate at the north entrance that can be closed for the most part, but able to open as needed for busier times at the cemetery: Memorial Day, Veteran's ceremonies, etc. or to let large equipment in as needed. This will be discussed again at the December meeting and a vote will be taken to decide if the north entrance will be closed.

- 8. Superintendent/Director's Report Shelters, rest rooms and fountains have been winterized. Lights were repaired at the pickleball courts and in McHose Park. Hazard tree contract completed- added one tree to the list for a total of \$17,675. Completed stump grinding list for NE part of town. 32 stumps removed. Replaced 19 small underwater lights in the pool with LED lights. Spot painted the bottom of the pool and some necessary depth markers. One double door left to replace at the pool (filter room-CIP project). Ken Slaba completed the Certified Pool Operator training.
