## STATEMENT OF COUNCIL PROCEEDINGS

January 15, 2024 6:00 p.m.

The City Council of Boone, Iowa, met in regular session in the City Hall Council Chambers on January 15, 2024, at 6:00 p.m. with Mayor Stines presiding. The meeting was also available via Zoom. The following Council Members were present: Byrd, Henson, Moorman, Hilsabeck, Williamson, and Angstrom. Absent: none.

Moorman moved; Williamson seconded to approve the agenda with the removal of 3A, Ames Economic Development Commission (AEDC) 4<sup>th</sup> Quarter Report. Ayes: Henson, Moorman, Hilsabeck, Williamson, Angstrom, and Byrd. Nays: none.

Hilsabeck advised there will not be a January 31, 2024 Public Safety meeting.

Ades presented the 2023 Tax Abatements stating that the applications totaled \$2,765,603.76 in residential improvements and 691,000.00 in commercial improvements. Moorman moved; Hilsabeck seconded to approve Resolution 3162 approving Tax Abatement Applications for 2023. Ayes: Moorman, Hilsabeck, Williamson, Angstrom, Byrd, and Henson. Nays: none.

Andrews reported that the Public Works Department has logged in about 770 hours of snow plowing, used 1400 gallons of fuel, and 70 tons of salt over the past eight (8) days.

Williamson advised that the Main Street Application Workshops are January 31, 2024, and February 5, 2024, 10:30 a.m. to 2:30 p.m. at the Ericson Library.

Cornelis advised that the roads through McHose Park and Cemetery have reopened.

Chief Adams requested authorization to apply for two (2) Assistance to Firefighters Grants (AFG) to purchase a City owned ambulance and a vehicle exhaust removal system; these grants do require a 5% local City match. Bryd moved; Moorman seconded to authorize the Fire Department to submit two (2) grant applications to purchase a City owned ambulance and a vehicle exhaust removal system. Ayes: Hilsabeck, Williamson, Angstrom, Byrd, Henson, and Moorman. Nays: none.

Skare presented the Special Election calendar, the election date is March 5, 2024.

Moorman moved; Byrd seconded to approve Resolution 3163 forbidding the wearing of hats in the Council Chambers during City Council meetings. Ayes: Williamson, Angstrom, Byrd, Henson, Moorman, and Hilsabeck. Nays: none.

Chief Adams stated that the Rental Department is working on complaints from tenants regarding not having heat and working with the landlords.
