A message from Fire Chief Justin Adams

Welcome to the Boone Fire Department 2018 Annual Report. You will find in this report information on the service provided by your fire department and what it takes to provide those services.

2018 again set a new record for incident responses and was our busiest year ever with 1,590 calls for service. This again is a 6% increase in calls and a 15% increase over the last 2 years. Additionally, the department completes rental inspections, commercial business/school inspections, code reviews and site visits, station tours, smoke detector battery replacement drive and multiple public event standby's.

I was happy to report in December of 2017 with effective date of April 1, 2018 that Insurance Service's Organization (ISO) had completed their evaluation of the Fire Department and rewarded the department with a Public Protection Classification class 3/3Y. Our previous classification was a 6/9. The department has been working hard through training, maintaining staffing, working with Public Works and Water Department to maintain fire hydrants and water supply along with Boone County Communications Center on keep their dispatch equipment up to date. This improvement has direct reflection on lowering home owners and business insurance premiums.

2018 was year one of a two-year agreement with the Boone County Hospital in which the fire department staffed a 3rd out ambulance provided by the Boone County Hospital. This agreement benefits the community with the assurance that we are able to now have 3 staffed ambulances to cover the entire county. With this agreement the fire department continues to train staff to the Paramedic level.

This report is just a snap shot of what your fire department completes on a day to day basis and we thank you for the support to be able to complete these tasks. If there are other statistics that are not provided in this report please feel free to contact me and we will get the requested information to you.

Facilities Facts

Fire Station:



The original Firehouse was built in 1938 attached to the North end of the City Hall. Today, the original portion of the station houses Rescue 8-67, Command 8-64, Tanker 8-65 and Attack 8-68 with the Gator. The second floor contains the living quarters for the on-duty crew.

Fire Department Annex:



The Annex was built in 1979 to accommodate the fleet that grew both in quantity and size to meet the increasing need for Fire Department services. Today, the Annex contains offices for the Fire Chief and on-duty crew, loft storage, gear storage, and houses Engine 8-62, Engine 8-61, Engine 8-63 and Truck 8-66.






Alarms by District (City vs. Rural)



Type of Alarm Summary




Alarms by District (Townships)





Alarms by Month




Alarms by Day

January

1st: In an agreement with the Boone County Hospital, the Boone Fire Department began EMS transport with a Boone County Ambulance staged at BFD headquarters for 3rd out Ambulance calls at a provisional Paramedic level.

12th: Structure Fire-514 Madison St.

Firefighters responded to smoke coming from the exterior wall of the house. The on-duty crew responded and extinguished a fire in the siding.

18th: Structure Fire-2205 290th St.

While the on-duty crew was responding to a fire alarm, callback Firefighters assisted Kelly Fire in eastern Boone County with a duplex fire. The building was destroyed but many personal belongings were recovered.

19th: Structure Fire-553 Keen Ave.

Firefighters responded to a fire in a home. The on-duty crew extinguished a fire in the back of the residence and the attic. The home was heavily damaged but there were no injuries.

21st: Structure Fire-1402 13th St.

Firefighters responded for a fire in the attic of a home. Residents noticed embers falling from around a ceiling fan and called 911. The fire was quickly extinguished with minimal damage and no injuries.

February

16th: Structure Fire—111 Monona St.

Firefighters responded for a fire in the attic of a duplex. The on-duty crew quickly extinguished the fire with minimal damage to the building.

March

4th: Semi Rollover—1900 block of 230th St.
Firefighters responded for a cattle semi
rollover on Highway 30. Crews spent over 5
hours extricating cattle from the damaged
trailer and cleaning up the crash. The driver
suffered minor injuries but several cattle were



4th: Structure Fire-1115 11th St.

While crews were still operating at the semi rollover, callback crews responded to a house fire. Firefighters arrived and extinguished a fire in the basement. Boone Fire was assisted by the Ogden and Stratford Fire Departments.

19th: Firefighter/EMT Andy Hull was sworn in as Boone Fire's 89th career Firefighter.

April

1st: Field Fire-696 X Ave.

Firefighters responded to an uncontrolled ditch fire spreading into a field. The on-duty and callback crews extinguished the fire after it consumed approximately 2 acres of pasture.

6th: Ditch Fire—1900 block of Highway 30

Firefighters responded to a ditch fire along the highway. On-duty crew responded from a medical call and callback crews responded to extinguish approximately 1/4 mile of ditch burning.

April (continued)

7th: Uncontrolled Fire—300 block of W 15th
Firefighters responded to an out of control
brush fire. On-duty crew arrived and found
grass burning that had extended to a shed and
camper. The fires were extinguished by onduty and callback crews.



11th: Structure Fire-466 190th St.

Firefighters responded to assist the Ogden Fire Department with a structure fire that had extended to other nearby structures. BFD assisted with tanker support and manpower.

24th: Structure Fire-1135 193rd St.

Firefighters responded to a fire in an outbuilding. Crews extinguished the fire and were able to recover some personal property. The structure was heavily damaged.

24th: Structure Fire—41 U Ave.

Firefighters responded to assist the Stanhope Fire Department with a structure fire that had extended to other buildings. BFD assisted with tanker support.

25th: Kitchen Fire—1723 Mamie Eisenhower Ave.
Firefighters responded to a fire in the kitchen of Toby K's Hideaway. Crews extinguished a fire in the kitchen and overhauled the area.
There were no injuries but the fire caused the kitchen to be closed until repairs were made.

29th: Wildland Fire—Ledges State Park
Firefighters responded to a brush fire in
Ledges State Park. As the fire was well offtrail, equipment had to be walked back and
made extinguishment difficult. The fire was
extinguished within 3 hours and confined to
under 1 acre.

May

7th: Firefighter/EMT Cody Bunning was sworn in as Boone Fire's 90th career Firefighter. This added position increased Boone Fire's full-time division to 9 Firefighters.

20th: Pancake Breakfast

The Boone Firefighters Association hosted it's Annual Pancake Breakfast Fundraiser and raised several thousand dollars to update power tools and hand tools on our apparatus.



June

3rd: Training Burn—123 W 15th St.

Firefighters conducted a training burn on an acquired structure. This provided an opportunity for us to practice fire attack in a controlled setting along with other realistic training.

4th-8th: Youth Emergency Services Academy
The Boone Fire and Police Departments
hosted a Youth Academy, allowing high school
students an inside look at Emergency Services
in Boone.

June (continued)

19th: Structure Fire—127 S Story St.

Firefighters responded to smoke in a residence. On-duty crew located fire in the walls and ceilings which were extinguished by on-duty and callback crews. There was moderate damage to the home.



29th: Grain Rescue—1095 T Ave.

Firefighters responded to a person trapped in a pile of grain. Firefighters and bystanders used specialized grain rescue equipment to rescue the individual in under an hour with minimal injuries.

July

24th: RAGBRAI

Boone Fire assisted several riders while passing through.

August

1st: Structure Fire—904 W 6th St.

Firefighters responded to a reported structure fire. On-duty crew arrived to find fire coming thru the roof of a house. A fire in the attic was extinguished by on-duty and callback crews. The fire was contained to the attic and personal property was recoverable.

3rd: Corn Crib Fire-1587 J Ave.

Firefighters responded to assist the Ogden Fire Department with a corn crib fire.

11th: Anhydrous Leak—1294 S Ave.

Firefighters responded for an anhydrous odor. On arrival, several anhydrous tanks were found with small leaks. Firefighters along with facility staff stopped the leaks.

September

2nd: Structure Fire-621 W 8th St.

Firefighters responded to a smoke alarm and found a fire in the crawlspace of a home due to an issue with a dryer vent. The fire was extinguished by on-duty and callback crews with minimal damage to the home.

28th: Dryer Fire—1864 330th St.

Firefighters responded to assist the Madrid Fire Department with a fire in a grain dryer.

29th: Event Standby—Central Iowa Expo
Firefighters on standby at a concert provided
assistance to several injured or disabled
individuals during heavy rain and muddy
conditions.



October

11th: Open House

Boone Fire hosted it's Annual Open House with great turnout. Crews responded to two vehicle crashes and one fire investigation during the Open House but attendees had a great time.

24th: Combine and Field Fire—200 block of L Rd.
Firefighters responded to the 200 block of L
Road for a Combine and field fire. There was
significant damage to the combine but the
field fire was extinguished prior to extending
into standing grain. Boone Fire was assisted
by the Stratford Fire Department.



29th: Structure Fire-618 W 2nd St.

Firefighters responded to a garage fire. Onduty crew arrived to find fire and smoke coming from a garage. The fire was quickly extinguished. There was moderate fire damage to the garage and heavy smoke damage to contents.

November

Smoke Detector Battery Drive

The Boone Fire Department and Boone Professional Fire Fighters Local 678 held our annual battery drive, replacing hundreds of batteries in smoke and carbon monoxide detectors across Boone for residents who needed assistance.

4th: Structure Fire-315 State St.

Firefighters responded for a fire in a residence. On-duty crew responded and on a quick interior attack, extinguished a fire in the kitchen. Callback crews assisted with clearing heavy smoke from the residence and searching for missing pets.

13th: Ag Equipment Fire—1294 S Ave.

Firefighters responded to a machinery fire.

On-duty crew arrived finding smoke coming from a fertilizer leg. Crews disassembled the equipment to access the fire and check for extension into adjoining bins.

December

2nd: Chicken Coop Fire—1896 210th St.

Firefighters responded to a fire in a chicken coop. On-duty crew arrived and extinguished a fire in the chicken coop. All of the animals survived.


18th: Structure Fire—1158 Jonquil Ave.

The Boone Fire Department hosted its annual Retirees Lunch, bringing together past and present members of the Fire Department.


